Sports Hub Garmin Sports Sessions Rewards

The Garmin Sports Sessions Rewards (“Garmin Sports Sessions Rewards”) to be held at Singapore Sports Hub (“Venue”) is introduced by SportsHub Pte Ltd (“SportsHub”) for a period of validity from 1 January 2020 to 31 December 2020 (“Promotion Period”). The Garmin Sports Sessions Rewards include the Monthly Lucky Draw.

Participants of Garmin Sports Sessions Rewards

Participants of any Garmin Sports Sessions during the Promotion Period will be eligible to earn points and redeem rewards from 3 different tiers by completing an action. Action refers to a participant’s attendance at any of the Garmin Sports Sessions and participants are required to download the ELXR® App (available on the App Store/Google Play Store) in their mobile devices to complete the action which is a collaboration between Singapore Sports Hub and ELXR®.

Participants who have earned (a) 500 points (Tier 1), (b) 1000 points (Tier 2), and (c) 1500 points (Tier 3) will be eligible to redeem a reward. Rewards can be seen at the “Garmin Sports Session” tab of the [website](#).

A total of 1,500 points (60 actions x 25 points) can be earned by each individual during the Promotion Period, where one (1) action constitutes 25 Points.

Participants who participate in the Garmin Sports Sessions and checked-in via the ELXR® App will be automatically enrolled into the Monthly Lucky Draw. The Monthly Lucky Draw will take place at the end of every month. Winners will be informed via their email in the first 2 weeks of the following month.

Rules & Regulations of the Garmin Sports Sessions Rewards

1. The qualifying period for the Garmin Sports Sessions Rewards is only during the Promotion Period.
2. Participants are required to register for any of the Garmin Sports Sessions through the ELXR® App by selecting the “Going” button on their desired Garmin Sports Sessions Rewards. Participants must attend the Garmin Sports Sessions Rewards to complete the action and be eligible for earning of points.
3. Points will only be issued on the day of the Garmin Sports Sessions and each participant can only earn points once per Garmin Sports Session Rewards.
4. Participants will be entitled to one (1) reward for 500, 1000 and 1500 points earned respectively.
5. The points are non-transferable and must only be used by the registered account holder
6. All rewards cannot be exchanged for cash and will not be replaced if lost or stolen.
7. The rewards are subject to availability and will be issued on a first-come first-served basis (while stocks last). Rewards may be replaced by SportsHub at its sole discretion.
8. All rewards must be redeemed by 31 December 2020 (“Claim Period”). Unclaimed prizes after the Claim Period will be automatically forfeited and shall become null and void. The participant shall not be entitled to any compensation whatsoever.
9. All prizes for Monthly Lucky Draw must be redeemed within 30 days from the date of receiving the email notification. Unclaimed prizes after 30 days will be forfeited and shall become null and void. The Winner shall not be entitled to any compensation whatsoever.

Sports Hub Garmin Sports Sessions Rewards Terms and Conditions

1. **General:** These terms and conditions ("T&Cs") apply to the Sports Hub Garmin Sports Sessions Rewards ("Garmin Sports Sessions Rewards") organised and operated by SportsHub Pte Ltd ("SportsHub"). By taking part in the Garmin Sports Sessions Rewards, the participants shall be deemed to have agreed to be bound by the terms and conditions of the Garmin Sports Sessions Rewards.
2. **Prohibited Parties:** Employees of SportsHub, its subsidiaries, divisions, affiliates, agents and partners (the "Representatives") and their immediate family members are not eligible to enter into or participate in the Garmin Sports Sessions Rewards. Any other persons or companies professionally connected with the Garmin Sports Sessions Rewards or directly involved in organizing, promoting, operating or conducting the Garmin Sports Sessions Rewards are not eligible to enter into or participate in the Garmin Sports Sessions Rewards.  - (c) void an entry of or disqualify a participant; and
 For the avoidance of doubt, SportsHub shall be under no obligation to provide reasons or justifications for exercising any of its rights above. SportsHub hereby expressly reserves its rights to pursue legal action against any individual believed to have undertaken fraudulent activities or other activities harmful to this Garmin Sports Sessions Rewards and/or the entry submission process.
5. **Cancellation:** SportsHub hereby expressly reserves its rights to cancel and terminate the Garmin Sports Sessions Rewards at its sole and absolute discretion and without notice and further liability to any participant.
6. **Privacy:** Personal data may be collected, used and/or disclosed by SportsHub for the following purposes:
 - (a) facilitating and administering the Garmin Sports Sessions Rewards;
 - (b) for use in publicity and promotional materials (publicity purposes); and
 - (c) sending marketing updates and messages of SportsHub's events, activities and promotions by electronic mail.
 In the course of carrying out the purposes, SportsHub may disclose the participant's personal data to its affiliates, subsidiaries and/or third party service providers. SportsHub shall adhere to the Personal Data Protection Act 2012 in its collection, use and/or disclosure of the personal data collected from the participants. SportsHub and each participant hereby agrees to irrevocably and unconditionally submit to the exclusive jurisdiction of the courts of Singapore. These T&Cs shall not confer any rights to any third party under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any term of them.
