CONDITIONS OF ENTRY TO PRECINCT AND OTHER AREAS SURROUNDING THE FACILITIES OF THE SINGAPORE SPORTS HUB (“T&Cs”)

Welcome to the Singapore Sports Hub, a world-class, integrated sports, entertainment, and lifestyle hub delivering world-class sporting and entertainment events. The Singapore Sports Hub has been developed by and is operated by SportsHub Pte. Ltd. (“**SportsHub**”, which terms includes its employees, agents and other authorised representatives).

The T&Cs apply to the visitors of the Singapore Sports Hub for the safety and enjoyment of all visitors. In addition to the T&Cs, if you are visiting the Singapore Sports Hub to attend or participate in a specific event or activity, other additional Conditions of Entry may apply. Please refer to the specific Conditions of Entry terms and conditions printed on the ticket for the event or activity, set out at the entry points to the relevant facilities and/ or <https://www.sportshub.com.sg> relating to the relevant event, facility booking and/ or activity.

By entering the area of Singapore Sports Hub, you consent to be bound by the T&Cs as well as, where relevant, additional Conditions of Entry applicable within any facility and/or in relation to any specific event or activity you attend or participate in.

1) Conduct

- a) Visitors to the area of Singapore Sports Hub are required to:
- i) comply with all directions and/or announcements from SportsHub, including without limitation the directions to move on, and any other instructions relating to access, order, behaviour and safety given by SportsHub or governmental or regulatory authorities;
 - ii) maintain safe, prudent and respectful behaviour at all times;
 - iii) be responsible for their own property, pets and/ or minors accompanying them;
 - iv) to ensure that their equipment or other property do not obstruct or otherwise interfere with access to escape routes and corridors, landings and stairwells, and/ or in any manner adversely affect the enjoyment of the facilities at the Singapore Sports Hub by other visitors.

2) Restricted Activities

- a) Visitors shall not:
- i) carry out, attempt to carry out or facilitate any act or omission which would be detrimental to or compromises safety;
 - ii) carry out, attempt to carry out or facilitate anything which involves or otherwise relates to a noisy, dangerous, illegal or immoral purpose, or do or suffer to be done in or upon the Singapore Sports Hub anything that may be or become a nuisance or annoyance or cause damage or injury to the Singapore Sports Hub (including without limitation injury to the Singapore Sports Hub’s reputation, the other visitors or occupiers);
 - iii) behave in a disorderly fashion;
 - iv) wear or display commercial, political or offensive signage or logos or such other signage or logos without prior agreement of SportsHub ;
 - v) entry to an area prohibited to the general public within the Singapore Sports Hub, through unauthorised or illegal means;
 - vi) refuse to produce valid identity documents, be inspected or submit their belongings for inspection for prohibited items to representatives of SportsHub;

- vii) smoke within the Singapore Sports Hub, except at specifically designated smoking areas;
- viii) carry out, attempt to carry out or facilitate any form of commercial and/or business activity and/or enterprise including without limitation ambush marketing, distribution of flyers, good, samples and/or other promotional materials, personal training, sale or promotion of any goods or services (legal or otherwise), professional coaching or dog walking and filming, without prior agreement of SportsHub;
- ix) participate in or organise overnight or unauthorised queue formation;
- x) camp, sleep overnight or otherwise establish, or attempt to establish, temporary or permanent living quarters at any part of the Singapore Sports Hub;
- xi) failure to keep their dog(s) under control, on a lead or muzzled in accordance with the Animals & Birds (Dog Licensing & Control) Rules;
- xii) ride bicycles or use roller skates/ blades or skateboards outside of designated routes;
- xiii) litter;
- xiv) fish;
- xv) fly kites;
- xvi) swim – except in permitted facilities;
- xvii) use naked flames whether for BBQs or otherwise; and
- xviii) use and/ or operation of drones of any kind, or other unmanned aircraft or remote controlled flying devices without prior agreement of SportsHub
- xix) affix or display on any part of the Singapore Sports Hub any name, sign, notice, poster, banner or advertisement;
- xx) use screws, nails, masking tape, duct tape, double-sided tape, or any devices of any description likely to deface or otherwise damage the walls, floors or ceilings on any part of and/ or any property in the Singapore Sports Hub.
- xxi) use or otherwise bring to the Singapore Sports Hub any item which SportsHub deems in its absolute discretion as dangerous, illegal, offensive, disruptive or may cause a nuisance, including but not limited to:
 - (1) weapons, or resemblance of weapons, including but not limited to knives, firearms, blunt offensive objects/batons and those with sharp ends;
 - (2) fireworks/flares or flammable or dangerous substances;
 - (3) illegal substances including controlled, dangerous or illicit drugs;
 - (4) musical instruments and noise makers including but not limited to portable stereo systems, drums, whistles, vuvuzelas, air horns and loud hailers without the prior consent of SportsHub’s management;
 - (5) projectile items which are reasonably considered by SportsHub as being able to cause injury, nuisance or offence to another person including balls (unless for use within designated Community Facility e.g. Basketball Court), frisbees, rackets or similar objects;
 - (6) banners or flags larger than 1m x 2m without prior agreement of SportsHub;
 - (7) vehicles, power-assisted bicycles and personal mobility devices,

(“Restricted Activities”).

- b) If visitors wish to carry out any Restricted Activity, SportsHub’s prior written approval must be obtained. Such approval shall be such terms and conditions that SportsHub may impose in its absolute discretion and may be withdrawn at any time.

- c) If and where the use of bicycles and personal mobility devices are permitted to be used in areas shared with pedestrians and/ or other vehicles, visitors who use them must at all times ensure they:
 - i) ride in an orderly manner, with due regard for the safety of others;
 - ii) have checked that their bicycles and/ or devices are compliant with all laws, rules and regulations;
 - iii) dismount and push if riding amongst pedestrians;
 - iv) give way to pedestrians
 - v) observe safe speed limits;
 - vi) for bicycles:
 - (1) switch on the white light in front and red light at back of bicycle during hours of darkness;
 - (2) do not use electric bicycles;
 - (3) are parked in areas designated for that purpose;
 - vii) do not ride against the flow of traffic;
 - viii) do not overtake others when approaching places such as pedestrian crossings, corners and bends;
 - ix) keep a safe distance from other users to avoid collisions;
 - x) do not weave between pedestrians and other traffic;
 - xi) keep in good condition the bicycle and/ or device;
 - xii) stop to render assistance and exchange particulars when involved in an accident.
- d) Without prejudice to its other rights and remedies, SportsHub reserves the right to stop Restricted Activity.
- e) Without prejudice to its other rights and remedies, SportsHub reserves the right to refuse entry or remove any person who carries out a Restricted Activity. SportsHub also reserves the right to ban any person from the Singapore Sports Hub area for a specified period. SportsHub will refuse entry or remove from the Singapore Sports Hub any person who has been banned.

3) Photographs, Images and Recording

- a) The use of any recording, data or image taken within the Singapore Sports Hub without SportsHub's consent for commercial gain, public advertisement, display or any other purpose, except for private non-commercial purpose, is prohibited.
- b) Any person who makes, reproduces or uses any recording, data or image for use prohibited under clause 3(a) shall assign in writing of all copyright and intellectual property rights to SportsHub at his or her own cost.
- c) Equipment including but not limited to CCTV, film cameras and sound recording are present at the Singapore Sports Hub. By entering the Singapore Sports Hub area, visitors consent to being filmed and recorded and for SportsHub and its authorised representatives to use the visitors' image, likeness and any sound recording for any media or other purposes including public transmission, advertising or promotional purposes, without payment or claim to copyright or intellectual property rights. Visitors consent to their images and recordings being shared with police and other authorities if SportsHub deems it appropriate.

4) General Conditions

- a) SportsHub may postpone, cancel, interrupt or stop the use, or deny access to the Singapore Sports Hub area in the event of maintenance works, adverse weather conditions or for other reasons without prior notice, and without any compensation to the visitors.
- b) Visitors must ensure all rubbish is disposed in the relevant bins designated for that purpose.

- c) School groups must be sufficiently accompanied by accompanying adults during their visit in Sports Hub.

5) Liability

- a) SportsHub shall not be liable (to the extent permitted by law) for any death, injury, loss, damage or inconvenience howsoever caused to or sustained by any visitors to the Singapore Sports Hub.
- b) Each visitor shall indemnify and hold harmless SportsHub against all claims, demands, actions, judgements, damages, losses, costs and expenses of any nature which SportsHub may suffer or incur for any death, injury, loss or damage caused by any act or omission in the use of the Singapore Sports Hub by such visitor or his/ her pet(s) or minors under his/ her charge or by a breach of the T&Cs.

6) Miscellaneous

- a) Please note SportsHub reserves the right to vary the T&Cs without prior notice.
- b) If any of the T&Cs shall for any reason be determined by any court or tribunal to be illegal, invalid or unenforceable, then the remaining terms and conditions or part thereof shall not be affected, impaired or invalidated and shall remain in full force and effect and shall continue to be binding on visitors to the Singapore Sports Hub.
- c) Any relaxation, forbearance, indulgence or delay (together “**indulgence**”) of SportsHub in enforcing any of the T&Cs shall not be construed as a waiver of its right and shall not affect the ability of SportsHub to subsequently to exercise that right or to pursue any remedy, nor shall any indulgence constitute a waiver of any other right (whether against that party or any other person).
- d) The T&Cs shall be governed and construed in accordance with laws of the Republic of Singapore and the courts of Singapore shall have exclusive jurisdiction in case of any dispute.
