



## Sports Hub Festival of Football: Guess The Winner contest

### **Sports Hub Festival of Football – Guess The Winner**

The Guess The Winner contest (“Contest”) to be held at Singapore Sports Hub (“Venue”) is introduced by SportsHub Pte Ltd (“SportsHub”) for a period valid from 14 June to 15 July 2018 (“Contest Period”).

### **About the Contest:**

As part of the Sports Hub Festival of Football, patrons will get the opportunity to try and guess the winner of every World Cup match screened at the event. Winners stand to walk away with Kallang Wave mall vouchers and other great prizes from Sports Hub!

Participants of the Contest will need to do the following:

1. Pick up a prediction slip at the Festival of Football booth. Slips are only available one hour before every match and each session of the contest will close when the match kicks off.
2. Complete the prediction slip with their personal details.
3. Drop the prediction slip in any of the 3 lucky draw boxes. Each box will be represented by the participating countries of the match and a box for a draw result.
4. Participant will receive a stamp to indicate that they have dropped their slip into the box for each match.
5. One winner will be picked from the winning box after the match is over.

### **Rules & Regulations of the Contest**

1. The qualifying period for the Contest is only during the Contest Period. All redemptions of the Guess The Winner have to be completed at the Festival of Football by the participant themselves during point of announcement. Late redemptions will not be allowed.
2. The Guess The Winner prediction slips are only available one hour before every match. Each contest session will close once the match kicks off.
3. Participants will only be entitled to one prediction slip. Multiple entries are not allowed.
4. The Contest shall be subject to the terms and conditions set out below. By taking part in the Contest, the participants shall be deemed to have agreed to be bound by the terms and conditions of the Contest and to the collection, use and/or disclosure of their personal data for the purposes set out therein.
5. The judge's decision is final and no correspondence will be entered into.
6. All prizes cannot be exchanged for cash and will not be replaced if lost or stolen.
7. The winners are strictly prohibited from selling and reselling the prizes to a third party.
8. Unclaimed prizes after the Claim Period will be automatically forfeited and shall become null and void. The winner(s) shall not be entitled to any compensation or whatsoever.
9. All entry particulars submitted must be accurate, true and complete. Incomplete, inaccurate or illegible entries will be disqualified.



### Sports Hub Guess The Winner Terms and Conditions

- General:** These terms and conditions ("T&Cs") apply to the Sports Hub Guess The Winner contest organised and operated by SportsHub Pte Ltd ("SportsHub"). By taking part in the Sports Hub Guess The Winner contest, the participants shall be deemed to have agreed to be bound by the terms and conditions of the Sports Hub Guess The Winner contest.

  - request a winner to present their NRIC or other proof of identity for verification purposes;
  - void an entry of or disqualify a participant; and
  - draw reserve winners to replace any successful winner(s) who may subsequently be found to be ineligible and disqualified or for such other reason that SportsHub may determine in its reasonable discretion.For the avoidance of doubt, SportsHub shall be under no obligation to provide reasons or justifications for exercising any of its rights above. SportsHub hereby expressly reserves its rights to pursue legal action against any individual believed to have undertaken fraudulent activities or other activities harmful to this Sports Hub Guess The Winner contest and/or the entry submission process.
- Cancellation:** SportsHub hereby expressly reserves its rights to cancel and terminate the Sports Hub Guess The Winner contest at its sole and absolute discretion and without notice and further liability to any participant.

  - for use in publicity and promotional materials (publicity purposes); and
