



## **Our Singapore Campaign Redemption T&Cs**

### **Our Singapore Campaign Redemption**

The Our Singapore campaign ("Campaign") to be held at Singapore Sports Hub ("Venue") is introduced by SportsHub Pte Ltd ("SportsHub") for a period valid from 1 to 31 August 2019 ("Campaign Period").

### **About the Campaign:**

Bring home your very own Singapore Sports Hub otter plush toy when you purchase any of the SG54 packages or spend a minimum of \$80 around Singapore Sports Hub.

SG54 packages include:

- 1) Kayak Orientation Programme for 2 pax at \$54
- 2) 30-Day Fitness Class Pass for \$54
- 3) 1 hr Stingray rides for 2 pax at \$54

Participants of the Campaign will need to do the following:

1. Purchase any of the SG54 packages or spend a minimum of \$80 around Sports Hub.
2. Present the receipts to the information counter at Visitors Centre for redemption within Campaign Period.

### **Rules & Regulations of the Campaign**

1. The qualifying period for the Campaign is only during the Campaign Period. All redemptions of the Campaign must be completed at the Visitors Centre by the participant themselves by 31 August 2019. Late redemptions will not be allowed.
2. Redemptions of otters and SG54 packages are while stocks last.
3. Receipts can be combined throughout the Campaign Period.
4. Minimum spending excludes purchases from Kallang Wave mall and Sports Hub Tix.
5. Only 1 redemption per every purchase of the SG54 package or a min. of \$80 spending.
6. Venue/programme usage is subjected to respective venue conditions of entry.
7. The Campaign shall be subject to the terms and conditions set out below. By taking part in the Campaign, the participants shall be deemed to have agreed to be bound by the terms and conditions of the Campaign and to the collection, use and/or disclosure of their personal data for the purposes set out therein.

    - for use in publicity and promotional materials (publicity purposes); and
    - sending marketing updates and messages of SportsHub's events, activities and promotions by electronic mail.

SportsHub shall adhere to the Personal Data Protection Act 2012 in its collection, use and/or disclosure of the personal data collected from the participants.
