

SNAP! Photography Contest

The SNAP! Photography Contest (“Promotion”) to be held at Singapore Sports Hub (“Singapore Sports Museum”) is introduced by SportsHub Pte Ltd (“SportsHub”) for a period valid from 23 March 2019 to 30 June 2019 (“Promotion Period”).

About the Contest

Participants of the Contest will need to do the following:

1. Entry format: Single photo in any format.
2. Images must be at least 2.9MB
3. Images must be taken between **23 March 2019 to 2359 hours on 30 June 2019**

Rules & Regulations of the Contest

1. The qualifying period for the Contest is only during the Promotion Period. All entries must be submitted by 2359hrs on 30 June 2019 to be eligible for the Contest. Late entries will not be permitted.
2. Participants are entitled only one entry for this Contest and are only eligible for one redemption of the prize.
3. The winners with the best submission will be selected by SportsHub Pte Ltd c/o Singapore Sports Museum team based on creativity and originality.
4. By submitting an entry, the participant warrants and represents that:
 - (a) the submission (including any written description and photo) is original work which has not been previously published;
 - (b) s/he owns all rights to the photo as well as the descriptions used in the entry,
 - (c) the submission is not infringing or in violation of any intellectual property rights or proprietary rights of any third party,
 - (d) the submission is not pornographic, obscene, defamatory, libellous, anti-social, seditious or in any way contrary to public policy in any way or in violation of any applicable laws of Singapore.
 - (e) the images submitted are not Internet images or stock images whether bought or copied.
 - (f) all the intellectual property rights especially the copyright in the photograph submitted is given to SportsHub Pte Ltd who shall own all rights, title and interest in the photograph and be the sole and exclusive copyright owner. Participant agrees not to use, make derivative works, copy, distribute, broadcast or display the photograph, or any part of the photograph, without the express permission of SportsHub Pte Ltd. Credit to the photographer will be given each time the photograph is used.
5. The Contest shall be subject to the terms and conditions set out below. By taking part in the Contest, the participants shall be deemed to have agreed to be bound by the terms and conditions of the Contest and to the collection, use and/or disclosure of their personal data for the purposes set out therein.
6. SportsHub shall contact the winners via email within five (5) working days after the results of the Contest have been evaluated.
7. All prizes will not be replaced if lost or stolen.
8. Unclaimed prizes after 1700hrs on 31 August 2019 will be automatically forfeited and shall become null and void. The winner shall not be entitled to any compensation or whatsoever.
9. All particulars submitted must be accurate, true and complete. Incomplete, inaccurate or illegible entries will be disqualified.



SNAP! Photography Contest Terms and Conditions

 - void an entry of or disqualify a participant; and
 - draw reserve winners to replace any successful winner(s) who may subsequently be found to be ineligible and disqualified or for such other reason that SportsHub may determine in its reasonable discretion.For the avoidance of doubt, SportsHub shall be under no obligation to provide reasons or justifications for exercising any of its rights above. SportsHub hereby expressly reserves its rights to pursue legal action against any individual believed to have undertaken fraudulent activities or other activities harmful to this SNAP!
