



## Sports Hub Ultimate Football Family Contest

### **Sports Hub Ultimate Football Family Contest**

The Sports Hub Ultimate Football Family Contest ("Promotion") is to be held at Singapore Sports Hub ("Venue") and is introduced by SportsHub Pte Ltd ("SportsHub") for a qualifying period of validity from 14 June 2018 to 15 July 2018 ("Promotion Period").

### **About the Contest:**

Participants who have managed to display the ultimate football family spirit at the Singapore Sports Hub Festival of Football by completing the tasks set out will stand a chance to win one of the thirteen prizes.

Participants of the Contest will need to do all of the following:

1. Register online at [www.sportshub.com.sg/FoF](http://www.sportshub.com.sg/FoF)
2. Attend the Singapore Sports Hub Festival of Football and complete the Ultimate Football Family Card by collecting a sticker for at least 1 activity at participating venues of the Singapore Sports Hub Festival of Football to complete the card with 15 stickers.;
3. Purchase a minimum of one ticket to at least one of the 2018 International Champions Cup in Singapore matches; and
4. Share the experience at the Singapore Sports Hub Festival of Football on their Facebook and/or Instagram and hashtag #SSHFestivalofFootball in the caption.
5. Five shortlisted participants will enter a final round on 15 July 2018 to determine the order of the Grand Prize, Second Prize and Third Prize winner. The remaining participants will receive Consolation Prizes.

### **Prizes:**

1. The Grand prize includes the following:
  - (a) Flights and 2 nights' accommodation for two to London, Paris or Madrid for an Adult and a Child;
  - (b) Two tickets to watch Arsenal, Atlético de Madrid or Paris Saint-Germain home match for an Adult and a Child;

  - (a) One Player Escort Pass (only eligible for children between the ages of 6 to 12 years old) to a 2018 International Champions Cup in Singapore match;
  - (b) Four Passes to a 2018 International Champions Cup in Singapore Official Training Session;
  - (c) Four tickets to a 2018 International Champions Cup in Singapore match;
  - (d) Four Season Passes to all 2018 Singapore Premier League matches;
  - (e) Four tickets to a 2018 Suzuki Cup match; and
  - (f) One Family 3-month Singapore Sports Hub Access Pass (applicable for up to 4 people).
3. Third prize includes the following:
  - (a) One Player Escort Pass (only eligible for children between the ages of 6 to 12 years old) to a 2018 International Champions Cup in Singapore match;
  - (b) Four Passes to a 2018 International Champions Cup in Singapore Official Training Session;
  - (c) Four tickets to a 2018 International Champions Cup in Singapore match;
  - (d) Four Season Passes to all 2018 Singapore Premier League matches;
  - (e) Four tickets to a 2018 Suzuki Cup match; and
  - (f) One Family 1-month Singapore Sports Hub Access Pass (applicable for up to 4 people).

4. 10 Consolation prizes, each of the 10 prizes include all of the following:
  - (a) Two Passes to a 2018 International Champions Cup in Singapore Official Training Session;
  - (b) Two tickets to a 2018 International Champions Cup in Singapore match;
  - (c) Two Season Passes to all 2018 Singapore Premier League matches;
  - (d) Two tickets to a 2018 Suzuki Cup match; and
  - (e) One Family 2-weeks Singapore Sports Hub Access Pass (applicable for up to 4 people).

#### **Rules & Regulations of the Contest**

1. The qualifying period for the Contest is only during the Promotion Period. **All entries must be submitted by 23:5900hrs on 8 July 2018 to be eligible for the Contest.** Late entries will not be allowed.
2. Shortlisted participants for the Grand Prize must be present at Singapore Sports Hub Festival of Football on 15 July 2018 to enter the final selection process.
3. Participants are entitled to unlimited entries for this Contest, but are only eligible for one redemption of the prize.
4. Participants are not allowed to combine multiple incomplete Ultimate Football Family Cards to achieve 15 stickers.
5. A maximum of 1 sticker can be collected per venue per day.
6. Only original Ultimate Football Family Cards will be accepted.
7. Any Ultimate Football Family Cards found to be tampered with will be considered null & void.
8. All Ultimate Football Family Cards will need to be completed with 15 stickers to qualify for the Promotion.
9. Original Ultimate Football Family Cards will have to be presented in order to redeem the prize if selected.
10. Original 2018 International Champions Cup in Singapore match ticket will have to be presented in order to redeem the prize if selected.
11. The winners with the best submission will be selected by SportsHub Marketing team based on creativity, originality and aesthetics of their social media postings displaying the ultimate football family spirit.
12. Participants must ensure that their Facebook and Instagram profiles are set to public so that SportsHub Marketing team is able to track submissions.
13. By submitting an entry, the participant warrants and represents that:
  - (a) the submission (including any written description and photo) is original work which has not been previously published;
  - (b) s/he owns all rights to the photo as well as the descriptions used in the entry,

14. Grand Prize winner must be redeemed by a Parent or Guardian [hereinafter Adult] and Child, and the pair will travel to Europe to watch one Arsenal, Atlético de Madrid or Paris Saint-Germain home match.
15. The Grand Prize winner must capture their match experience in Europe on video and share it on their social media platforms.
16. Player Escort Passes are only eligible for children between the ages of 6 to 12 years old.
17. The Contest shall be subject to the terms and conditions set out below. By taking part in the Contest, the participants shall be deemed to have agreed to be bound by the terms and conditions of the Contest and to the collection, use and/or disclosure of their personal data for the purposes set out therein.
