About the Contest:

There are a total of 3 Samsung S9+ mobile phones to be won!

Participants of the Contest will need to do the following:

1. Capture a photograph or video of their ultimate football fan moment at the Singapore Sports Hub Festival of Football
2. Post their photograph or video on their Facebook, Twitter or Instagram
3. Hashtag #SSHFestivalofFootball
4. 3 lucky winners will walk away with a Samsung S9+ mobile phone

Rules & Regulations of the Contest

1. The qualifying period for the Contest is only during the Promotion Period. All entries must be submitted by 0059hrs on 16 July 2018 to be eligible for the Contest. Late entries will not be allowed.
2. Participants are entitled to unlimited entries for this Contest, but are only eligible for one redemption of the prize.
3. Participants must ensure that their Facebook, Twitter and Instagram profile are set to public.
4. This contest is only open to all Singaporeans and permanent residents of Singapore, currently residing in Singapore.
5. The winners with the best submission will be selected by SportsHub Marketing team based on creativity, originality and aesthetics.
6. By submitting an entry, the participant warrants and represents that:
 - (a) the submission (including any written description and photo) is original work which has not been previously published;
 - (b) s/he owns all rights to the photo as well as the descriptions used in the entry,
 - (c) the submission is not infringing or in violation of any intellectual property rights or proprietary rights of any third party,
 - (d) the submission is not pornographic, obscene, defamatory, libellous, anti-social, seditious or in any way contrary to public policy in any way or in violation of any applicable laws of Singapore.
7. The Contest shall be subject to the terms and conditions set out below. By taking part in the Contest, the participants shall be deemed to have agreed to be bound by the terms and conditions of the Contest and to the collection, use and/or disclosure of their personal data for the purposes set out therein.
8. SportsHub shall contact the winners via Facebook, Twitter or Instagram message within five (5) working days after the results of the Contest have been evaluated.
9. All prizes cannot be exchanged for cash and will not be replaced if lost or stolen.
10. The winner is strictly prohibited from selling and reselling the prizes to a third party.
11. Unclaimed prizes after the Claim Period (*23 July 2018 to 10 August 2018*) will be automatically forfeited and shall become null and void. The winner shall not be entitled to any compensation or whatsoever. The unclaimed prize shall be given to the next contestant in line for the prize, in the event that there is no prize winner, the prize(s) shall be returned to the giver.
12. All entry particulars submitted must be accurate, true and complete. Incomplete, inaccurate or illegible entries will be disqualified.



Sports Hub Share the Football Fever Contest Terms and Conditions

1. **General:** These terms and conditions (“T&Cs”) apply to the Sports Hub Share the Football Fever Contest organised and operated by SportsHub Pte Ltd (“SportsHub”). By taking part in the Sports Hub Share the Football Fever Contest, the participants shall be deemed to have agreed to be bound by the terms and conditions of the Sports Hub Share the Football Fever Contest.
2. **Prohibited Parties:** Employees of the SportsHub, its subsidiaries, divisions, affiliates, agents and partners (the “Representatives”) and their immediate family members are not eligible to enter into or participate in the Sports Hub Share the Football Fever Contest. 4. **SportsHub’s Rights:** SportsHub hereby expressly reserves its rights in its sole and absolute discretion to:
 - (a) exclude any person from participating in the Sports Hub Share the Football Fever Contest;
 - (b) request a winner to present their NRIC or other proof of identity for verification purposes;
 - (c) void an entry of or disqualify a participant; and
 - (d) draw reserve winners to replace any successful winner(s) who may subsequently be found to be ineligible and disqualified or for such other reason that SportsHub may determine in its reasonable discretion.For the avoidance of doubt, SportsHub shall be under no obligation to provide reasons or justifications for exercising any of its rights above. SportsHub hereby expressly reserves its rights to pursue legal action against any individual believed to have undertaken fraudulent activities or other activities harmful to this Sports Hub Share the Football Fever Contest and/or the entry submission process.
5. **Cancellation:** SportsHub hereby expressly reserves its rights to cancel and terminate the Sports Hub Share the Football Fever Contest at its sole and absolute discretion and without notice and further liability to any participant.
6. **Privacy:** Personal data may be collected, used and/or disclosed by SportsHub for the following purposes:
 - (a) facilitating and administering the Sports Hub Share the Football Fever Contest;
 - (b) delivery of the prizes (including to contact the participant for the administration of the prizes);
 - (c) for use in publicity and promotional materials (publicity purposes); and
 - (d) sending marketing updates and messages of SportsHub’s events, activities and promotions by electronic mail.In the course of carrying out the purposes, SportsHub may disclose the participant’s personal data to its affiliates, subsidiaries and/or third party service providers. SportsHub shall adhere to the Personal Data Protection Act 2012 in its collection, use and/or disclosure of the personal data collected from the participants. 14. Miscellaneous: These T&Cs are governed by the laws of the Republic of Singapore. SportsHub and each participant and winner hereby agrees to irrevocably and unconditionally submit to the exclusive jurisdiction of the courts of Singapore. These T&Cs shall not confer any rights to any third party under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any term of them.
