Sports Hub Season of Giving: Christmas Ornament Auction

The Sports Hub Season of Giving: Christmas Ornament Auction ("Promotion") to be held at Singapore Sports Hub ("Venue") is introduced by SportsHub Pte Ltd ("SportsHub") for a period valid from 7 December to 20 December 2018 ("Promotion Period").

About the Auction:

Participants can support SportCares by bidding on a Christmas ornament autographed by Team Singapore Athletes and international Tennis legend, Billie Jean King. Participants will have to make a minimum bid of \$10 on the selected ornament. The top three bids on each athlete's ornament will be contacted as successful bidders to proceed to make their donation via www.giving.sg/vision2030/sportcares.

Participants of the Auction will need to do the following:

1. Click on the Google Forms link to select the ornament they would like to bid on:

2. Indicate the ornament they would like to bid on by keying the code name of the athlete shared on Sports Hub Facebook & Instagram posts.
3. Indicate the amount they would like to bid, with a minimum bid of \$10.00. Tax Deductible Receipts (TDR) will be issued by SportCares with a minimum donation of \$10.00.
4. The top three bids on each athlete's ornament will be contacted as successful bidders.
5. They will proceed to make their donation via www.giving.sg/vision2030/sportcares.
6. Please take note that all donations to SportCares are not refundable.

Rules & Regulations of the Auction

1. The qualifying period for the Auction is only during the Promotion Period. All entries must be submitted by 2359hrs on 20 November 2018 to be eligible for the Auction. Late entries will not be allowed.
2. Participants are entitled to unlimited entries for this Auction and are eligible for unlimited redemption.
3. This Auction is only open to all Singaporeans and permanent residents of Singapore, currently residing in Singapore.
4. The Auction shall be subject to the terms and conditions set out below. By taking part in the Auction, the participants shall be deemed to have agreed to be bound by the terms and conditions of the Auction and to the collection, use and/or disclosure of their personal data for the purposes set out therein.
5. SportsHub shall contact the winners via the email address or their contact number provided within five (5) working days after the results of the Auction have been evaluated.
6. All Christmas ornaments cannot be exchanged for cash and will not be replaced if lost or stolen.
7. The winner is strictly prohibited from selling and reselling the Christmas Ornament to a third party.
8. Unclaimed Christmas ornaments after the Claim Period (24 December 2018) will be automatically forfeited and shall become null and void. The winner shall not be entitled to any compensation or whatsoever.
9. All entry submitted must be accurate, true and complete. Incomplete, inaccurate or illegible entries will be disqualified.



Sports Hub Season of Giving: Christmas Ornament Auction Terms and Conditions
